A demonstration will be held on Friday from 11:30 am to 12:00 pm. Students must wear tights & leotard and have ballet & tap shoes. Ballet shoes may be worn for jazz. All dancers must be potty trained! No pull-ups allowed. You will receive an email one week prior to your camp with details pertaining to the camp.

Afternoon Summer Camps (3rd grade & older)

The class subject will determine what shoes you will need. Jazz shoes or foot undeez are okay for contemporary. All classes will require that the dancers are dressed modestly (no stomachs or bare legs showing)! We will divide the dancers up by age and/or skill level so that each dancer will learn and be challenged throughout the week. Parents are invited from 3:30-4 pm on Friday for a short demonstration.

Danceology morning camps will NOT have a demonstration. Dancers will need ballet and/or jazz shoes and tap shoes. Same dress code as described above.
